Financial conditions

1. Registration fees

One-time registration fee of CHF 300.-

2. Tuition fees

Tuition fees are payable :

- **Annually** : before the 1st of September. This payment benefits of **2% discount**.
- Per term : before the 1st of September, 1st of January, 1st of April.
- Monthly : before the 1st of each month from September to June.
- Optional (supervision, meal, prep) are billed together with the tuition fees.

In the case of late payment of either school fees or extra charges, Ecole Blancpain reserves the right to contract a company of its choice to undertake debt collection. The costs involved will be assumed by the debtor concerned.

Educational material

The school provides all the books and exercise books which will be billed once a year.

Special activities (ski, excursions) are billed separately.

Official exam

A registration fee will be billed to grade 9 students sitting the exam to obtain the Certificate of secondary education "Certificat d'Etudes Secondaires de l'Association Vaudoise des Ecoles Privées (AVDEP)".

3. Re- registration procedure for the following academic year

- A student is automatically enrolled for the following academic year as long as Ecole Blancpain or the parents do not demand otherwise.
- Parents wishing to withdraw their child from the school for the following academic year should do so in writing no later than 1st May.
- Ecole Blancpain will automatically renew enrolment and keep a place open for all students for whom no formal withdrawal has been submitted by 1st May.
- Parents will ensure that school fees for the coming year have been paid in accordance with the conditions outlined in point 2.
- If a registration is cancelled before the 30th June, all paid fees for the following academic year will be reimbursed; if registration is cancelled after this date, then the 1st month's fee is due, unless Ecole Blancpain can replace a pupil from its waiting list.
- A student will only be invited to return to Ecole Blancpain for the following academic year if all financial conditions have been respected.

4. Contractual financial conditions

- If a student is expelled from the school during the course of the term, the fees for that month alone are payable to Ecole Blancpain.
- If a student is withdrawn by the parents from the school during the course of the term, both the fees for that month along with those for the following month are payable to Ecole Blancpain.
- During the course of a term, should a student be withdrawn from Ecole Blancpain with the consent of both the parents and Ecole Blancpain, only fees for that month are due.

5. Contractual agreement and litigation

The parents undersigned confirm their agreement with the financial conditions set out in both this document and in the School Rules which they have received.

The contractual agreement between the parents, the child and the school is, in the final instance, subject to Swiss law.

Any case of litigation between the school, the students and the parents will be brought before the tribunal of La Tour-de-Peilz.

The term "parents" used in this document is understood to refer to the child's legal representative.

The undersigned, known as the legal representative of the student or students, has full knowledge of the general conditions of Ecole Blancpain and accepts the administrative and financial modalities with regards to the due dates.
